ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

*****There were at least three animals with overgrown hooves. The hooves on the rear feet of an adult female Audad sheep, the hooves on the left rear and right front feet of an adult male Audad sheep, and the hooves on all four feet of an adult female lbex goat were too long. These animals were located in the petting zoo area. Overgrown hooves can cause pain, changes in locomotion, and may harbor disease. A program for hoof maintenance must be established and the hooves on these animals must be trimmed.

HANDLING OF ANIMALS.

*****There were not sufficient public barriers in all areas of the facility. There was no barrier to keep the public from entering the non-human primate (NHP) barn. The NHP barn is located behind the grain bins used for food storage and approximately 150 feet past a gate that was open but could be closed and used as a public barrier. There also was not a barrier at the juvenile Llama and miniature bovine enclosure fencing outside the giraffe barn. The general public was feeding the animals through the fence with no attendant or barrier present. The absence of a barrier allows the public access to areas with dangerous animals and could result in harm to the animals and/or public. The public must be restricted from entering areas with dangerous animals and a barrier must be present in areas that don t have an attendant present.

ENVIRONMENT ENHANCEMENT TO PROMOTE PSYCHOLOGICAL WELL-BEING.

*****There was no documentation specifying the extra enhancement required for single housed young juveniles and the great apes. There was a five-month old male Capuchin monkey housed in the giraffe barn. The Capuchin could not see other non-human primates of its own species. There are also two adult chimpanzees housed at the facility. The lack of special considerations for these animals may lead to psychological distress and stereotypical behavior. The licensee must provide extra enrichment for these


