This change should have had IACUC approval. Brodifacoum was to be fed in the food was instead put into water and gavaged. This may have changed the results and should have been approved IACUC. The potentially painful procedure of the cardio centesis was not approved by the IACUC.

Protocl # 07-13008: The facility has not documented that a search was conducted for alternatives to the potentially painful procedures for the rabbit protocol. The search and discussion is needed to ensure that there are not better ways to do the teaching. The researcher's staff changed the protocol and did a cardio centesis and then recovered the rabbit.

Review of some daily clinical treatment records for 2005:

Non human primate, MMU 29349: Cefazolin was to be given three times per day: January 17, 2005, the third dose was either not given and not initialed or not initialed. January 19, 2005, the first dose was either not given and not initialed or not initialed.

Non human primate, MMU 30647: Cefazolin and oxymorphone were to be given three times per day: March 4, 2005, the middle treatment was either not given and not initialed or not initialed.

Non human primate, MMU 30040: Cefazolin was to be given three times per day: December 19, 2005, the first dose was either not given and not initialed or not initialed. December 21, 2005, the second dose was either not given and not initialed or not initialed. December 22, 2005, the first dose was either not given and not initialed or not initialed.

Review of some daily clinical treatment records for 2006 at the regional primate center: August 9, 2006: Pages 1-4 of 14: thirty animals with 43 treatments were not initialed. Page 10 of 14: two animals with 2 treatments were not initialed.

March 13, 2008:	Page 1 of 2: one animal with 1 am treatment was not initialed.
March 14, 2008:	Page 2 of 7: two animals with 2 treatments were not initialed.
March 16, 2008:	Page 2 of 6: four animals with 7 treatments were not initialed.
June 19, 2008:	Page 1 of 1: one animal 1 treatment was not initialed.

Page 2 of 8: one animal with 2nd treatment was not initialed.

Numerous animal clinical records were reviewed for 2005, 2006, and 2008. Either the prescribed medications were not given or were not recorded. After talking to the staff, with the system in place, most likely, the med's were given but records were not initialed. Medications are prepared and if anything was not given, it would still be at the prep area. However, the only way to assure that the medications were given is to have records. A method to double check the records for accuracy needs to be instituted. A supervisor or other designated person could review records to assure that they are complete. This is to assure that animals' health and well being are being maintained.

Correction: Additional monitoring of the entries is recommended.

Sec. 2.38 Miscellaneous. (b) Access and inspection of records and property.

(1) Each research facility shall, during business hours, allow APHIS officials: (i) To enter its place of business; (ii) To examine records required to be kept by the Act and the regulations in this part (iii) To make copies of the records; (iv) To inspect the facilities, property, and animals, as the APHIS officials consider necessary to enforce the provisions of the Act, the regulations, and the standards in this subchapter; and (v) To document, by the taking of photographs and other means, conditions and areas of noncompliance.

Non human primate: MMU 30647: the records for August 4, 2005 were not available for review. It is necessary for these records to be available to assure that the animals were properly cared for. The facility could not find this particular day of records for treatment.

In the future, have a retrieval system that so records don't get misplaced or lost.
